INTRODUCTION

With the theme “**Celebrating Spanish-Philippines Connection through Commerce and Culture**” this year’s Forum will be held on 19th-21st March 2025 in Madrid and Cuenca.

The forum will comprise forth comprehensive sessions, covering the following topics:

- Language and culture as public goods
- The EU-Philippines Free Trade Agreement
- Port-to-port cooperation in the field of decarbonization and sustainability
- Water resources management
- The legacy of Fernando Zobel

The first session, entitled: “**Cultural and linguistic exchanges between Spain and the Philippines**”, will explore the situation of the Spanish language in the Philippines, as well as the opportunities for bilateral cooperation in the field of culture.

This will be followed by the second session, themed: “**EU-Philippines Free Trade Agreement: current status of negotiations and future prospects**”. In March 2024, the EU and the Philippines agreed to resume negotiations for an ambitious free trade agreement (FTA). Should the negotiations be concluded positively, the tariff reductions, the simplification of non-tariff barriers, the opening of the government procurement market and other aspects will enhance trade and investment relations between Spain and the Philippines.

The third session is entitled “**Port-to-port cooperation in the field of decarbonization and sustainability**”. The ports of Spain and the Philippines share the objective of focusing on environmental measures, such as reducing carbon emissions, controlling water pollution, and improving energy efficiency. This session will discuss some of the best practices in the management of Spanish and Philippine ports in the area of sustainability.

The fourth and the last session will be devoted to “**Water resources management**”. Water management is the set of actions and processes that make it possible to plan, allocate, and optimize the use of water resources. The aim is to ensure that water needs are met without compromising sustainable development. Due to the scarcity of water resources, cooperation between Spain and the Philippines in this area could help to optimize water use and minimize environmental impact.

The fifth and the last session, which will take place in Cuenca, will focus on “**The legacy of Fernando Zobel: perspectives from Spain and the Philippines**”. Fernando Zobel, the Manila-born painter and founder of the Museo de Arte Abstracto de Cuenca was an innovator in the field of abstract art. He has been one of the artistic figures who have contributed most to relations between Spain and the Philippines, acting as a cultural bridge between the two countries.

Distinguished speakers and experts from the government, diplomatic, cultural and business communities will share their insights on possible collaborations. By understanding the multisectoral dimensions of their shared legacy, both nations can better navigate the current landscape and create a future characterized by strengthened partnerships.
